ENERGY STAR® occasionally removes products from qualifying lists, and the cooperative will not rebate products that have been delisted as of the purchase date or are mislabeled as ENERGY STAR®. Call the cooperative to verify rebate program status.

Important:

- Rebates \$300 and under will be issued as a credit to the electric bill. Any rebate greater than \$300 will be issued as a check. MCPA reserves the right to issue rebates as a credit on the electric bill if the member's account is in a "past due status". Allow 6-8 weeks for processing.
- Maximum rebate of \$2,500 per member per year, except for storage space heating \$5,000 maximum.
- Qualifying rebate amounts – \$200 variable speed pump and \$400 air source heat pump pool heater.
- Equipment must be installed within cooperative's service territory.
- Fill out this form completely. Incomplete forms will not be processed.
- Include your account number.
