Celebrating

85 Years

Eighty-five years ago, our rural ancestors were living in the dark—but McLeod Co-op Power brought power and hope to rural Minnesota by forming an electric cooperative.

We were formed by visionaries to serve you and that remains our most important goal today.



McLeod Co-op was chartered as a corporation by the state of Minnesota on October 3, 1935, and work quickly began building the first power lines. May 29, 1937, marked the culmination of years of planning and organization when the first power lines were energized. McLeod County farmers and rural residents could turn on and use their electric lights and power for the very first time.

It did not take long for electricity to transform life in rural America and for safe, reliable electricity to become expected. Today we plug in our cell phones, televisions, gaming systems, and modern appliances without even thinking. Most people cannot even imagine life without electricity.

Eighty-five years and countless hours of hard work later, McLeod Co-op Power is a modern, dynamic electric cooperative dedicated to providing safe, reliable, efficient electricity to its members.

We celebrated our anniversary on October 20th with a drive-up donut event. While the celebration looked different due to COVID-19 than what we hoped for at the beginning of the year, we were still honored to serve our members and our community in recognition of this significant milestone.

New

Building

After several years of planning and twelve months of construction, the new McLeod Cooperative Power combined facility is a reality.



Located in Glencoe's East Industrial Park, our new headquarters remains in a central location within our service territory, which is a key factor in outage response times. The sturdy, pre-cast concrete structure and emergency generator provide a safe and reliable space to operate, especially during large storms when power outages are most common.

The demand for a new facility was driven by the need for a new garage and warehouse. The new facility gives us space to gain efficiencies and provide better service to our member-owners. By resourcefully consolidating all our resources in one facility, we have improved response times in emergency situations and made other efficiencies to help serve our members for years to come.

We are also happy to report that our old pole yard was purchased by Arnold's of Glencoe and Sam's Tire is leasing our former headquarters with the intent to purchase in 2021.

Operations

Highlights

The ability to accommodate increasing loads and new services, along with keeping existing substations and distribution equipment operational is essential to delivering quality service.

2020 was another busy year for our operations department as they worked tirelessly on distribution system improvements.







Construction

Crews installed 230,885 feet of primary underground wire and 8,190 feet of secondary wire. In addition, they removed 223,205 feet of overhead primary line and 3,593 feet of secondary overhead wire. Crews continue to be busy with new construction and service upgrades for members while working on the Co-op's work plan.

Maintenance

In an effort to keep the distribution system in its best condition, crews changed out 145 poles, tested 226 transformers, changed out 289 inefficient yard lights to LED lights. In addition, crews completed line patrol on 1,459 miles of overhead line and made any necessary repairs. Underground equipment was also inspected and repairs were made as identified.





Reliability

On average consumers experienced 1.5 outages in 2020 and the average length they were out of power was 81 minutes. On average consumers had power for 99.985% of the time. Throughout the year, crews completed required maintenance work and cleared vegetation within our right-of-way to proactively prevent outages and improve reliability.

Safety

Safety on the lines is the first priority at your Co-op. Linecrews had several trainings in 2020 focusing on a variety of safety topics. Unfortunately crews and staff were not able to visit schools or community groups in 2020 due to the COVID-19 pandemic, but safety messages were instead, posted to our Facebook page.



Operation Round Up

Through the Operation Round Up® program, McLeod Co-op Power gives our members the opportunity to give back to the community. Each month the rounded-up funds (between 1¢ and 99¢) are placed in a trust fund and administered by the volunteer Trust Board.

In 2020, donations totaling \$21,100 were made to 19 local organizations. McLeod Co-op Power's Operation Round Up® program has awarded nearly \$130,000 thousand totaling 163 donations to local nonprofit organizations and community service programs since the program's inception in 2004.

McLeod Co-op Power started the process of converting Operation Round Up® to an opt-out program in 2020. With the change, the Co-op conducted an outreach campaign to educate the membership about the virtues of the program to give members an opportunity to decide if they would like to participate in the program.

July 21, 2020 | Hutchinson Event Center

Due to the COVID-19 Pandemic, the meeting was held following the Center of Disease Control and Prevention (CDC) social distancing guidelines.

The Annual Meeting was called to order by President Keith Peterson on June 16th, 2020 at 10:00 A.M. Having failed to establish a quorum of members present at the Meeting on June 16th, 2020, the Meeting was adjourned to a later date and time to be determined by the Board of Directors.

The Annual Meeting was reconvened by President Keith Peterson at 10:00 A.M. on July 21st, 2020.

President Peterson welcomed members to the 85th Annual Meeting. President Peterson also introduced Ronald Meier as the Cooperative's new General Manager/CEO. General Manager/CEO Meier comes to the Cooperative after serving as the Manager of Engineering and Member Relations of La Plata Electric Association in Durango, Colorado. General Manager/CEO Meier worked for La Plata Electric Association for nearly 27 years with a diverse management background both in engineering and member service departments.

A quorum was established and verified by President Keith Peterson and Secretary-Treasurer Doug Kirtz.

Secretary-Treasurer Doug Kirtz read the "Notice of the Cooperative's Annual Meeting" and declared that the Notice had been properly published in an official newspaper in McLeod County.

President Peterson declared the balloting closed and instructed the tellers to count the ballots for the director election and Articles of Incorporation and Bylaws.

President Peterson called for a reading of the 2019 Annual Meeting minutes.

A motion was made, seconded, and carried to dispense with the reading of the minutes.

A motion was made and seconded to approve the Minutes of the 2019 Annual Meeting as printed in the Annual Report. Motion carried.
