- Rebates \$300 and under will be issued as a credit to the electric bill. Any rebate greater than \$300 will be issued as a check. MCPA reserves the right to issue rebates as a credit on the electric bill if the member's account is in a "past due status". Allow 6-8 weeks for processing.
- Maximum rebate of \$5,000 per member per year. Rebates are on a first-come, first-serve basis while rebate funds remain available.
- Check with cooperative for qualifying rebate amount.
- Rebated product must be installed within Cooperative service territory.
- Fill out this form completely. Incomplete forms will not be processed.
- Include your account number and sign the form.
