UPDATE YOUR CONTACT INFORMATION

At McLeod Co-op Power, we rely on data for nearly every aspect of our operations, which is why we need your help. By making sure we have your most accurate and complete contact information, we can continue to provide the high level of service that you expect and deserve. Accurate information enables us to improve customer service and enhance communications for reporting and repairing outages. It also allows coop members to receive information about other important programs, events and activities.

Up-to-date contact information can potentially speed up the power restoration process during an outage. For example, the phone number you provide is linked to your service address to our outage management system. This means when you call to report an outage, our system recognizes your phone number and matches it with your account location. Accurate information helps our outage management system predict the location and possible cause of an outage, making it easier for our crews to correct the problem.



While we always do our best to maintain service, we occasionally plan outages to update, repair or replace equipment. In these instances, we can provide advance notification to affected members if we have your updated contact information and communication preferences. Keeping your information updated also helps us reach you if there is a question about your energy use or billing.

Your contact information is not shared, but is only used by McLeod Co-op to send important information to you. Please take a moment to confirm or update your contact information by calling our office at (800) 494-6272 or logging into your SmartHub account online.

MAY 2022 BOARD MEETING HIGHLIGHTS

The Regular Meeting of the Board of Directors of McLeod Cooperative Power Association was held on May 24, 2022, at McLeod Co-op headquarters. Nine board members, the attorney, CEO Ron Meier, and department managers participated in the meeting.

Highlights of the meeting included:

- Operations Manager Brady reviewed the April 2022 outage report with a total of 49 outages, affecting 145 consumers.
- A motion was carried to accept the action of the 2022 Nominating Committee for Districts 7, 8, and 9.
- Accountant Martin presented the Operating Statement and Balance Sheet for April 2022 for review.
- A motion was carried to approve Resolution 2022-05-01 Restatement of the RS and 401K Plans.
- A motion was carried to approve Resolution 2022-05-03 CoBank Authority.
- A motion was carried to approve Policy 5-11 Employee Recognition - Longevity Award.
- A motion was carried to approve rescinding Policy 5-15 Extended Service Appreciation.
- A motion was carried to approve a bill credit for an overage charge of the reservation fee involving a commercial account.

2022 CANDIDATE PROFILES

The Nominating Committee is required to select two names in each of these districts to appear on the ballot. Below are the candidates they have selected for Districts 7, 8, & 9.

DISTRICT 7

Collinwood Township in Meeker County, and Hale and Hutchinson Townships in McLeod County.



Randy Hlavka, Incumbent

Randy had a 39-year career as an electrician, serving as a Master Electrician for Hutchinson Technology and installing computerized energy controls for UHL company at various commercial and industrial firms in the state. He raised his family in Hutchinson Township and currently resides with his wife Jenny in Hale township enjoying grandkids, gardening, animals, and the open space. Randy has served on the McLeod Coop Power Board of Directors for the past 9 years. For the past 8 years, he has served as the Great River Energy representative for the Cooperative. His past community involvement has included serving as a church elder for First Presbyterian Church, Legion Commander, sportsman member. and member of the Disabled American Veterans organization. Randy believes some important issues for the Cooperative include evaluating time of use rates and other rate design options to provide choices for members to fit their service needs. Long-term goals include renewable energy sources, distributed energy, electric vehicles, and electric storage. He'd also like to see the Cooperative continue to focus on steady rates as well as listening to members to meet their needs.



Byron Bettenhausen

Byron lives in rural Hutchinson with his wife Katie where they raised their two boys, Brandon and Trenton. He has been employed by Alliance Pipeline for 23 years. He is a certified Jet Engine Mechanic and does pipeline work from the North Dakota border down south to St. Peter MN. He obtained an AAS degree from Bismarck State College in Power Plant/Power Process Operations. Byron previously served on the Hutchinson School Board for 9 years (Vice-Chair for 4 years) and Renville County Fair Board for 12 years (President for 6 years). Byron believes it will be important for the McLeod Co-op Power Board to consider renewable energies, while also ensuring that both reliability and affordable energy for consumers are still prioritized. He believes communication is a strength for the Cooperative and he'd like to make sure this continues. Investing in rebates for equipment investments and load management programs would be other continued focus areas for bene both the Cooperative and its members. Byron offers over 27 years of experience in the energy industry. He believes this experience would help him contribute to new ideas and good discussions. He looks forward to the possible opportunity to work with the other Board members and management team to provide leadership for the Cooperative.

DISTRICT 8

Alfsborg, Bismark, Grafton, Moltke, and Transit Townships in Sibley County, Bandon, Martinsburg, and Wellington Townships in Renville County, and Collins and Round Grove Townships in McLeod County.



Keith Peterson, Incumbent

Keith is currently the District 8 Director. This is his twelfth year serving on the McLeod Co-op Power Board of Directors. He has operated his farm in rural Hector for the past 45 years. Keith and his family are members of Swedlanda Church, where he has served as a chairman of the church board. Other leadership positions in the community include serving as a director for the Buffalo Lake-Hector School Board and president of the Hector Farmers Elevator. Additionally, he has served as the chairman and clerk for Martinsburg Township. Other volunteer work includes 27 years with the Hector Lions Club. Keith believes having affordable electrical rates and reliable service are priorities for our Cooperative. He also would like to see the Cooperative continue to invest in its infrastructure such as converting overhead lines to underground. Keith looks forward to working with the other directors and employees on a strong long-term future for the Cooperative and its members.



Mark Taylor

Mark lives in rural Brownton. He worked in the field of law enforcement and public safety for 27 years with a focus on policing, fire protection, and emergency management. This included 20 years with the McLeod County Sheriff's Office, which included holding the position of Chief Deputy Sheriff. He also served as the Director of Public Safety for the City of Northfield MN. Mark holds a Bachelor of Science degree from Mankato State University. His professional experience includes an array of administrative roles including budgeting, hiring, and training. He also has extensive experience working with various boards, commissions, and constituents. Mark has been active with the churches that he has attended including serving on the Board of Trustees and Church President for Bethlehem United Methodist Church. In the past, he also coached youth football for many years. Mark would like to see the Cooperative plan for its future by anticipating equipment replacement and changes in the industry. The board should make sound decisions that balance long-term growth addressing operations, equipment, technology, and staffing needs. He would like to see the Cooperative continue to focus on customer service and communications as well as the already strong outage response efforts.

DISTRICT 9

Susan Anderson, Incumbent

Susan is retired and currently helps run a small farm with her husband. She has served on the McLeod Co-op Power Board of Directors since 2019. Her professional career included serving as a corporate attorney for twenty years. After retiring as an attorney, she assisted her husband in running an automotive repair shop. She also held several positions with two food cooperatives and an Aldi grocery store. Her career has given her extensive training and experience in cooperative operations, budgeting, and strategic planning. In 2021, she became a Credentialed Cooperative Director through the National Rural Electric Cooperative Association by completing a series of educational courses on the electrical industry. Susan is a volunteer with the Midwest Organic & Sustainable Education Service and a member of the Minnesota Sustainable Farming Association. Her priorities for the Cooperative are to focus on stable and reasonable rates as well as providing electrical power that is both reliable and sustainable. Susan's long-term initiatives include expanding the customer base as well as developing renewable energy sources and the infrastructure to support the growth of electric vehicles.



Jeff Caswell

Jeff and Shonna have been McLeod Co-op Power members for 20 years. They live in rural Young America near Baylor Park. After graduating high school in 1982, he worked with his dad at Caswell Plumbing & Heating in NW Iowa. Along with residential plumbing and HVAC, they also did commercial work including schools, hospitals, and a wide variety of mechanical contracting. Jeff's niche within the business was water and wastewater treatment plants for municipalities and rural water systems all over western lowa, southwestern MN and South Dakota. FIVE TIPS FOR HIRING AN ELECTRICIAN

A licensed electrician can help with a variety of home projects from lighting upgrades to full renovations. Keep the following tips in mind if you're looking to hire an electrician.



LICENSED & QUALIFIED

Hire a licensed, qualified electrician for the job.

Look for a master electrician to manage the project. Master electricians have the most experience and will often oversee the work of a journeylevel electrician or apprentice.



INSURED

Make sure the electrician is insured.

Seasoned electricians know the importance of protecting themselves in case of an accident.



READ REVIEWS

Read all the reviews.

BUDGET & QUOTES

Determine your budget. Get two quotes.

Knowing your budget upfront helps move the process along. Prices can greatly vary, so get multiple quotes (at least two).



TIMELINE

Talk timeline.

Some electricians accidentally overbook projects. If your job is time-sensitive, convey that early on and discuss a realistic timeline with the electrician.

Saving money is always a tempting prospect for people to attempt DIY repairs around the home. However, certain projects need professional assistance. One perfect example is the home's electrical work. One of the main benefits of using a licensed electrician is that you gain access to professional expertise. Many of these electricians have years of experience in the industry and training under their belt. They can quickly identify the source of the problem with your electrical system and help to solve any issues without sacrificing safety or quality. Safety is another important consideration. Working on electrical equipment is a dangerous task that can cause fire or electric shocks if you make a mistake. An electrical job is not a hit-and-miss project.
