### **KEY STEPS WHEN CONSIDERING SOLAR**

As prices decline and technology improves, installing a residential solar system—makes sense for some consumers. However, even with these recent improvements, it's important to find out the facts before committing to a purchase. Follow these simple steps to explore whether solar is right for your situation.

**GET EDUCATED** Understand whether a solar photovoltaic (PV) system will work for you to offset your electric energy use. Other technologies like air source heat pumps, ground source heat pumps, and insulation reduce demand for fuels needed to heat your home and might be a better fit depending on your energy use or the solar resource available at your home.

**DO YOU HAVE A SUNNY SITE?** There are many considerations you should make before choosing solar. It's important to think about a variety of factors such as the efficiency of a building, the age and pitch of the roof, tree coverage, local weather patterns, and orientation to the sun. Typically, a good site is one that has a southfacing exposure and little to no shading. You can get a sense for the solar resource at your site using the MN Solar Suitability App (solar.maps. umn.edu/app). A solar site assessor can help you decide which technologies are the best fit for your home. Assessments will provide insight on the solar resource and potential structural or electrical issues. Most solar installers can provide you with a detailed site assessment.

**PLANNING AND ZONING** It's important to check in with your local city or county about ordinances that might impact your solar project. Though many ordinances consider on-site solar installations as accessory uses, some require setbacks or structural assessments, for example.

YOUR BUDGET While most solar installers will provide a bid that should give you a sense of the costs involved, make sure that you plan for all the possible financial considerations. Estimated energy savings, rebates or financial incentives, hidden costs, upfront payments and more should all be accounted for in your decision making. There are many incentives available that make solar more affordable. A federal tax credit can cover part of

the project cost for those with tax liability, and the USDA Office of Rural Development provides REAP grants and loans for farms and rural businesses. Members should do their own research to make sure any solar project fits their budget and makes financial sense to proceed based on the estimated expenditures and projected payback.

**SEEK ADVICE** McLeod Co-op Power can provide one-on-one assistance. If you are looking to implement solar and you want to talk it over, just give us a call or send us an email. We are ready to help you determine the best option and navigate the interconnection process.

In Minnesota, consumers cannot legally install solar until after they have applied for interconnection to the power grid, met the requirements for a safe installation, and been approved to interconnect. Contacting your co-op ahead of time can save you money and time. To begin the process visit us online at www.mcleodcoop.com/services/ renewableenergy/ and then follow the link to the NOVA Power Portal to access application forms, requirements, tariffs, etc.

# **2023 TREE TRIMMING**

Trees can add tremendous value to our homes and communities. However, trees growing near power lines present some real challenges. Fast-growing, tall trees (such as poplars, elms, willows and silver maples) located near or directly under primary wires can cause repeated outages. These trees have to be removed for safety and reliability purposes.

This year the Co-op is working with a new tree contractor, TreeStory. The bulk of this year's work will be happening on the west side of our service territory starting with the western side of District 4 (Kingman, Bird Island, and Norfolk townships). Work is anticipated to begin around the middle of March.



TreeStory will then work east through District 4 (East Lake Lillian, Oscelola, Melville, and Palmyra townships) and on any other remaining spots in this part of the service territory. Later this year (late summer or early fall) they will move to the east side of the service territory in the Carver County area to begin trimming trees in this area. We townships involved before work begins in this part of the service territory.

As a reminder, residents will receive a door hanger notifying them of the contractor working in their area about two weeks prior to the start of the work. The contractors vehicles and equipment will be recognizable with the company's logo decal shown below.


ChatGPT is only trained up to September 2021, and therefore doesn't have the most current info available. For example, it isn't aware that we are working on a time-of-use rate that will pair up nicely with EVs offering a much lower rate in the middle of the night for charging at home.

It also isn't aware of the build out of the charging infrastructure since 2021, which we have a long way to go still. It also isn't aware of the current level of tax incentives that are reducing the purchase price of EVs and the explosion of new EV models from most if not all the major car makers.

Now ChatGPT hit the nail on the head when it comes to the environmental consequences that we are still wrestling with in our society. Yes, there are challenges currently and ahead when it comes to sourcing the stuff we need to make an EV. Yes, today the electricity going into an EV still has fossil fuels being used to generate it. Some electricians accidentally overbook projects. If your job is time-sensitive, convey that early on and discuss a realistic timeline with the electrician.

- The board serves as ambassadors to our membership, community and legislative representatives. Directors are visible, active and available to members throughout their respective district.

#### **QUALIFICATIONS**

Directors must receive electric service from McLeod Co-op Power at their primary residence in the district they represent. Directors cannot be an immediate relative to an employee, employed by an enterprise that directly competes with or provides substantial services to the Cooperative, or have any other conflict of interest. A complete list of qualifications is located within the Cooperative Bylaws.

#### **COMMITMENT**

Directors serve a three-year term and must be available to attend monthly board meetings, the Annual Meeting, and additional training and/or conferences throughout their term. Board members are also expected to prepare for board meetings and serve as an ambassador for the Cooperative in the community.
