Substations play a critical role in the electric grid by facilitating the transmission and distribution of electricity from power plants to homes and businesses. They are responsible for changing the electrical voltage from high transmission levels to lower distribution levels, enabling the safe and efficient delivery of electricity to end-users. Substations also provide a way to manage the flow of electricity, ensuring that power is delivered where and when it is needed.

McLeod Co-op Power's 2nd largest substation, Bell Substation, will be replaced this summer to improve reliability and accommodate growth in our service territory. The existing substation originally built in 1955 was constructed of wood materials which no longer meets modern electric infrastructure standards, making an upgrade necessary.

The new substation will be built just to the east of the existing structure on a 3.8-acre neighboring site near Hwy 15 in Hassen Valley Township. The substation will be constructed of steel – which for obvious reasons stands up to harsh weather and is less prone to electrical fires. The size of the substation will also be increased to a 10 MVA Power Transformer and include five circuits serving electricity to Acoma, Hassen, Lynn, Collins, and Sumter townships. Distribution from this substation serves approximately 1,181 members through 177 miles of line and across 4,425 power

poles. The additional capacity of this substation positions the Co-op for additional growth in these areas as well.

One of the notable features of the new substation is the installation of electronic breakers, which will provide more detailed information for tracking and outage management. Additionally, the expansion of the site will provide a greater setback along State Highway 15, further reducing the risk of vehicle accidents and enhancing the overall reliability of the substation.

The construction of the new Bell Substation is scheduled to begin in June 2023, with a projected completion date of March 2024, depending on equipment availability. The estimated cost of the project is \$1.6 million.

Despite construction, electric service to our members will not be interrupted, and the existing substation will continue to serve the Bell substation territory until the new Bell Substation is completed.

The upgrade of the Bell Substation is an essential project that is designed to meet the needs of future growth and deliver reliable service for years to come. The upgrade is an investment in the future, and it demonstrates McLeod Co-op 's commitment to providing quality and dependable service to its members.

Longer lead times and supply chain delays make this all the more important in 2023.

### **MANAGER MESSAGE**

I'm pleased to be the guest columnist for this month's newsletter to provide an update on the results of the 2023 Member Survey. The survey was mailed out to our members earlier this year and we were fortunate to have 1,672 surveys returned.

The survey is designed to measure members' satisfaction on various topics. The Co-op generally conducts this survey every other year allowing us to analyze trends over longer periods of time. Below is a summary of several key survey categories from this year's survey.

#### **RELIABILITY OF ELECTRIC SERVICE:**

As with the other categories, members were asked to rate their satisfaction level with the three options being Poor, Satisfactory, or Excellent. This was one of our highest rated categories with 86% responding that the Coop is Excellent at providing reliable service (up from 79% in 2018). Furthermore, 80% of survey respondents rated us as Excellent for restoring power promptly (up from 72% in 2018). We appreciate receiving this feedback as reliability continues to be a key priority for us.

### **CUSTOMER SERVICE:**

Supporting our members is key to all we do, so this is an important area of focus for us. With this survey, 76% of respondents gave us an Excellent rating. We also scored the same rating when asking if we have helpful employees with 78%, giving us an Excellent rating. We will continue to focus on improvement given that 1% of respondents indicated a Poor ranking. To that point, I encourage members to consider signing up for SmartHub, as this can enhance your customer experience through various communication, such as text alerts, and online payment capabilities.

### **BOARD & MANAGEMENT:**

When asked to rate MCPA as a well-managed organization, 62% gave an Excellent rating (up from 54% in 2018). In fact, only 6 individuals of the 1,665 total respondents gave a Poor rating. Member engagement is key to ensuring the Co-op is a well-run organization. The Annual Meeting on July 11th at the Crow River Winery is another opportunity for just that.



#### **RATES:**

The Co-op scored the lowest satisfactory ratings within this category. With that said, ratings in this category have increased considerably since 2010. At the same time, 42% of respondents gave us an excellent rating for controlling costs and another 53% rated this as satisfactory. Even with these improved rankings, rates are and always will be a topic of discussion for the member owners, management team, and the Board of Directors.

### OTHER:

We also received some great feedback in the comments section. Some topics included electric vehicles, future energy sources, and our vegetation management efforts. These are great topics that we will be covering in the next couple editions of the newsletter to give members more information.

I'd like to thank all of you who returned your survey. Getting this input allows us to take a step back from our day-to-day activities and evaluate our work. Of course, getting input doesn't always have to take the shape of a formal survey. Our members are always welcome to stop by or call us if they have any ideas or feedback.

# APRIL 2023 BOARD MEETING HIGHLIGHTS

The Regular Meeting of the Board of Directors of McLeod Cooperative Power Association was held on April 25th, 2023, at McLeod Co-op headquarters. Eight board members, the attorney, CEO Ron Meier, and department managers participated in the meeting.

Highlights of the meeting included:

- The outage report for the month of March 2023 was reviewed with a total of 61 outages, affecting 128 consumers.
- A motion was carried to approve Resolution 2023-04-02 Bell Sub Station – Construction Contract Award to Highline Construction Inc.
- Tree Story representative and owner, Mark Kivisto, was invited to the meeting to present on vegetation management.
- Brian Stavenger from the accounting firm of Eide Bailly LLP presented the annual Audit Report to the board via Zoom for financial statements as of December 31, 2022.
- Manager of Finance, Jakel reviewed the March 2023 financials.
- A motion carried to approve Policy 5-7 Retirement, Insurance, and Savings Program.
- A motion was carried to approve Resolution 2023-04-01, Authorizing Amendment of 401(k) Pension Plan.

Summer is a time for fun in the sun, but it can also bring unexpected power outages due to severe weather, increased energy demand, or many other reasons. Losing power can disrupt your daily routine which is frustrating and could even be dangerous if you're not prepared. Here are some tips to help you prepare for summer power outages and stay safe:

- 1. Stock up on essential supplies: Make sure you have enough water, non-perishable food, and other essentials to last at least three days. Have a first aid kit and a supply of any medications you take. Also, stock up on batteries, flashlights, and other sources of light.
- 2. Protect your home: Invest in surge protectors to protect your electronics and appliances from power surges that can occur when the power comes back on. Unplug sensitive equipment before the outage is restored to prevent damage. If you're concerned about losing power for an extended period of time, consider investing in a backup power source, such as a generator. Be sure to follow all safety guidelines and hire a professional to install the generator if necessary.
- 3. Stay cool: Losing power during the summer can be uncomfortable and dangerous, especially for young children, the

elderly, and those with medical conditions. Plan ahead by purchasing battery-powered fans, portable air conditioners, or ice packs. You can also use a wet towel or spray bottle to cool down.

- 4. Know how to manually open your garage door: This may involve pulling a release lever or using a key to unlock the door from the outside.
- 5. Have a communication plan: Make sure you have a way to communicate with family members and emergency services during a power outage. Have a charged cell phone and a backup battery, or consider purchasing a solar-powered charger.
- 7. Stay informed: Stay informed about power outages in your area by signing up for alerts from your McLeod Co-op Power SmartHub account or follow our Facebook page. Have a battery-powered radio on hand to listen for updates and news.

Remember power outages can happen at any time, and being prepared is essential. By following these simple steps, you can make sure that you and your family are safe and comfortable during a summer power outage.



### **ENERGY EFFICIENCY**

The location of your thermostat can impact your HVAC system's ability to maintain an ideal indoor temperature. For maximum accuracy, thermostats should be placed in the center of the home, out of direct sun light or in a shaded area, or away from air vents, plumbing pipes and exterior doors. Avoid placing items like lamps and televisions near your thermostat, which can cause the HVAC to run longer than necessary.

## **MCLEOD CO-OP POWER DISTRIBUTES** \$46,500 IN OPERATION ROUND UP FUNDS

Through Operation Round Up, members donate pennies each month by volunteering to have their electric bills rounded up. In March 2023, the Cooperative and Operation Round Up® contributed \$46,500 to 20 area organizations. (See the complete list to the right.)

Operation Round Up is offered by hundreds of electric cooperatives across the United States. The program has raised millions of dollars for various charitable organizations and community projects, such as food banks,





health clinics, and educational programs. Here at McLeod Co-op alone, the Operation Round Up program has distributed over \$230,000 to local organizations since the program's inception in 2004.

One of the benefits of Operation Round Up is that it allows members to make a positive impact on their community with just a small contribution. The extra change from each member's bill may not seem like much, but when combined with the contributions of other members, it can add up to a significant amount of money that can make a real difference in people's lives.

Operation Round Up also allows McLeod Co-op to give back to the communities we serve in a meaningful way. As not-for-profit organization, McLeod Co-op is committed to improving the quality of life of our members. Operation Round Up is one way that we can fulfill this commitment by supporting local organizations and initiatives.

"While we can calculate how many dollars have been granted through Operation Round Up, there's no way for us to know the total number of lives that have been positively affected," said Bob Thomes, Assistant Member Services Manager. "It's just a few cents each month for our members, but that 'small change' adds up to make a huge impact.
