**RATE #14 – OPTIONAL PEAK ALERT RATE:** 50 kW Annual Peak Demand Minimum

**RATE #19 – LARGE POWER:** 75 kW – 500 kW Annual Peak Demand, either single phase or three phase

**RATE #20 – INDUSTRIAL:** Minimum demand of 500 kW, Three phase, 60 Hertz, metered at a substation.

Winter (Dec. – Feb.) @ \$23.04/kW
