Line Crossings & Switching for Building Moves

Initial Fee to plan and estimate the move \$500

**An estimate will be provided prior to the building move after the initial \$500 fee is paid. This fee for estimating as well as the estimated moving fees need to be paid prior to the work being completed. Upon completion of the building move, the actual costs associated with the move will be calculated and a final bill will be provided. A refund will be made if the paid estimate is greater than the actual costs.*

Other Miscellaneous Charge Work:

**Vehicle Charges are separate from labor.*

A. Labor Linework per hour (per employee)

1. Regular Time Rate \$120
2. Overtime Rate \$180
3. Double-time Rate \$230
4. Electrician Time \$105

B. Material

1. Replacement inventory costs, plus 15%
2. Non-MCPA customers, plus 45%

C. Vehicle Charges per hour

1. Aerial – bucket \$100
2. Digger \$100
3. Plow \$120
4. Stand-on Trencher \$75
5. Pickup \$45
6. Mini Excavator \$105
7. Trackloader & Attachments \$150
8. Dump Truck \$60
9. Vactor \$100
10. UTV \$40
11. Pole Trailers \$50

This rate applies when done in conjunction with work order construction.
If this is done when a special trip is necessary – charges will be actual cost.
