# MANAGER'S MESSAGE

#### UNDERSTANDING ELECTRICAL DEMAND – ONE COMMUTE AT A TIME

When I started working in the electric cooperative world back in 2014, I'll be honest — understanding electrical "demand" was confusing. In fact, it took me until just last year to really wrap my mind around it. Thankfully, I had the help of our CEO, who explained it in a way that made sense — by comparing it to something we all know: traffic.

Think about driving on I-494 in the Twin Cities during rush hour. That road was built to handle lots of cars moving at once, especially during the busiest times of the day. Keep that image in mind while we talk about electricity demand

Our electrical system is kind of like a highway. Just like a highway moves cars from one point to another, the electrical grid moves electrons (electricity) from the generating source to your home. Every time you turn on a light, use your microwave, or run the air conditioner, you're sending "cars" down that electrical highway. Now imagine it's over 100 degrees outside. You come home and, like everyone else, you turn on the AC, do laundry, cook dinner, and run the dishwasher — all at once. That's like rush hour for electricity. That's our electrical rush hour, typically between 5 PM and 8 PM.

Yes, the system is built to handle it, but just like roads wear out and traffic backs up, the power system also gets strained. It takes extra energy and effort (and cost) to keep up during these high-use times and to maintain reliability.



# **STEPH JAKEL**

Here's where it gets important: Great River Energy, our wholesale power provider, tracks when that "rush hour" happens each month — again, which is usually one hour between 5 PM and 8 PM. We're charged extra for that highest peak demand time, our version of rush hour, because it's when the system is under the most pressure. And guess what? That one hour can account for roughly 25–30% of MCPA's \$1 million monthly wholesale power bill.

Here's another way to look at it: out of every dollar you pay McLeod Cooperative Power, about 61 cents goes directly to paying Great River Energy. The more power we use during peak hours, the more we're charged. It's kind of like paying a higher toll for driving during rush hour.

But here's the good news: we can influence our power bill by shifting our collective energy use away from peak times. That's why understanding demand is the first step. Small changes—like running appliances earlier in the day or later at night—can help reduce the cooperative's peak demand and lower costs for everyone. It's all about driving smarter on the electrical highway.

Summer is here and so are rising temperatures. But staying comfortable doesn't have to mean higher energy bills. With a few smart adjustments, you can keep your home cool and energy efficient all season long.

#### START WITH YOUR THERMOSTAT.

Set it to 78°F when you're home and higher when you're away. Every degree you raise it can help lower cooling costs by up to 3%. Use ceiling fans to circulate air and help rooms feel cooler without adjusting the temperature.

#### **BLOCK THE HEAT.**

Close blinds or curtains during the hottest part of the day to reduce the amount of sunlight warming your home. Consider thermal or blackout curtains for extra insulation.

#### SHIFT YOUR ENERGY USE.

# STAY ALERT: DON'T FALL FOR UTILITY SCAMS

Scammers continue to target utility customers with increasingly deceptive tactics. Protect yourself and your household by staying informed and cautious.

#### 1. SLOW DOWN AND VERIFY:

If someone contacts you claiming to represent your utility, don't rush. Scammers often pressure you to act quickly—especially when it comes to payments. Take a moment to verify the request by calling McLeod Co-op Power directly using the number on your bill or the company's official website.

#### 2. WATCH FOR FAKE ENERGY AUDITS:

Be wary of unsolicited calls or visits offering "free energy audits" or claiming to represent your utility. These are often telemarketers or scammers looking to gain access to your home by promising rebates or savings. Legitimate audits from McLeod Co-op are scheduled at your request.

#### 3. DON'T PAY FOR POWER RESTORATION:

After storms or disasters, scammers may offer to restore your power sooner for a fee. This is a scam—utilities never charge for restoration or offer preferential service based on payment. Any necessary repairs to customer-owned equipment will be communicated through official channels.

#### 4. KNOW YOUR PAYMENT OPTIONS:

Never give payment to anyone who calls, emails, or comes to your door claiming to be from McLeod Co-op unless it's a verified method. Know your utility's official payment options: whether it's online, by mail, phone, or automatic bank draft.

#### **5. BEWARE OF OVERPAYMENT SCAMS:**

A common trick is to tell customers they've overpaid their bill and need to provide banking information to receive a refund. Don't fall for it. McLeod Co-op will either credit your account or issue a refund by mail.
