BE PREPARED – OUTAGES WILL HAPPEN!STAYING SAFE DURING SUMMER STORM SEASON

As summer heats up, so does the potential for severe weather. Thunderstorms, high winds, lightning, and even tornadoes can all threaten our electric system. While McLeod Cooperative Power works hard to maintain reliable service, summer storms can bring down trees, damage power lines, and knock out electricity sometimes for hours or even days.

So, the real question is: How prepared are you to be without electricity for an extended time period? Could your household manage if the power was out for a week?

This summer, we encourage all members to consider how they would handle an extended outage. Some planning now can make a big difference when the lights go out.

PLANNING AHEAD IS KEY

You don't need to go through survival training or build a bunker but having a few basic items and following some essential safety tips can help you and your family stay safe and comfortable if a storm knocks out the power.

Here are the critical supplies every household should have on hand, especially during storm season:

- A telephone that doesn't need electricity to operate. Cordless phones won't work in a power outage. Keep a corded landline phone or a fully charged cell phone with a backup battery or power bank.
- Water. Store at least three gallons of bottled water per person to get through several days without running water.
- Flashlights and extra batteries. Avoid candles, if possible, due to the risk of fire. Flashlights are safer and more reliable. Make sure to have extra batteries on hand!
- Canned food and a manual can opener. A pantry with non-perishable items means you won't be relying on perishables that spoil in a powerless refrigerator.

STORM SEASON...

- First aid kit and prescription medications. Make sure your medications are refilled and accessible, especially if you rely on refrigerated meds.
- Candles and matches. If you need to use these, do so cautiously as a backup lighting source. Keep them out of reach of children and never leave burning candles unattended.
- A battery-powered or hand-crank radio. Weather updates are critical during emergencies, especially if cell service is interrupted.
- A generator. While not a necessity for every home, generators can power essential items. If you choose to invest in one, always follow manufacturer instructions and never run a generator inside your home or garage due to the risk of carbon monoxide poisoning.

LISTEN AND STAY INFORMED

Weather conditions can change rapidly, and early warnings are critical. Pay attention to local weather updates, especially during watches and warnings for thunderstorms, high winds, freezing rain, or severe storms. Having a reliable source of weather information helps you make informed decisions about your safety and when to prepare for possible outages.

Also, review storm safety protocols with your family members, especially young children. Make sure everyone knows where the safest part of the house is during severe weather and understands when and how to take shelter. Having a designated plan can prevent confusion and save lives when minutes matter.


OUR COMMITMENT TO YOU

McLeod Cooperative Power takes storm preparedness seriously. We work year-round to maintain our lines, trim trees, and prepare our crews to respond quickly to outages. When a storm hits, our lineworkers and staff jump into action to restore power as safely and quickly as possible. But widespread or severe damage can take time to repair, especially if poles or transformers are down.

That's why we encourage all members to have a plan. Your preparation can help reduce stress, protect your loved ones, and make riding out an extended outage more manageable.

FINAL THOUGHTS

Summer storms are a fact of life in Minnesota, but being caught off guard doesn't have to be. Taking a few simple steps now can go a long way in protecting your home and loved ones. Preparedness is key to staying safe, calm, and resilient when the power goes out.



An overhead power line can become damaged or fall due to a severe storm, car accident, public damage or other reasons. If you see a downed power line, take these actions:



Consider all powerlines energized and deadly.



Stay at least 50 feet away.



Call 9-1-1 or the utility to report the downed line.



Do not approach it or try to move it with another object.



Do not get out of a vehicle or cab.



Do not approach the scene.



Warn others to stay away.



Turn around and go another way.

Even if you do not see a downed line, realize one could be hidden by storm debris, water, snow or ice.

OTHER THINGS TO KNOW

- Energized downed lines spread voltage through the ground or nearby objects.
- If you go near a downed line, you can become electricity's path to ground.
- You cannot tell if a power line is live just by looking at it.
- Even if a power line appears coated, it's never safe to go near it.
- While transmitting and distributing power is typically safe, extreme scenarios like downed power lines are extremely dangerous. Never approach a downed power line.

JUNE 2025 BOARD MEETING HIGHLIGHTS

The Regular Meeting of the Board of Directors of McLeod Cooperative Power Association was held on June 24, 2025, at McLeod Coop headquarters. Nine board members, CEO Ron Meier, and department managers participated in the meeting.

Highlights of the meeting included:

- The outage report for the month of May was provided with a total of 73 outages, involving 261 consumers.
- A motion carried approving an out-of-budget spend of \$54,000 to fix Digger Truck #1.
- Member Services Manager Ehrke provided an update on the Annual Meeting being held on July 15.
- Manager of Finance Jakel reviewed the May financials.
- A motion carried approving Policy 3-2 Investment of Cash.
- A motion carried approving Policy 3-3 Internal Control of General Funds.
- A motion carried approving the Strategic Plan Action

 Matrix
- A motion carried approving Director Susan Anderson to attend the NRECA 2025 Regions 5&6 Meeting.

2025 VEGETATION MANAGEMENT SCHEDULE

McLeod Co-op Power takes a proactive vegetation management approach to clear trees and overgrowth from power line rights-of-way with the goal of maintaining a safe and reliable electric system.

Our contractor, TreeStory, is continuing to work through our 2025 vegetation management priority areas, covering the following areas:

- Rich Valley
- Bergen
- Camden
- Young America
- Helen
- Glencoe (if time allows)

HOW YOU CAN HELP

- Watch for Notifications If work is scheduled in your area, you'll receive a door hanger notification about two weeks before it begins. Crews from TreeStory, our vegetation management partner, are working in marked vehicles with the company's logo for easy identification.
- Plant Wisely If you're planning to plant trees on your property, remember that large, tall-growing trees should be at least 50 feet from power lines to prevent future conflicts.
- Report Problem Trees If you spot a compromised tree near a power line, call us! We'll assess whether it falls under our responsibility or if the member needs to work with an independent tree service for assistance.

KEEPING OUR SYSTEM STRONG TOGETHER

By working together, we can ensure a more reliable electric system and a safer environment for everyone. Thank you for your continued support in keeping our right-of-way clear and our power lines safe.



DO NOT REMOVE YOUR METERWITHOUT CO-OP ASSISTANCE

Electricians and/or members are not authorized to pull an electric meter to perform work on a service.

Safety is a top priority for McLeod Co-op Power. Removing or adjusting electrical equipment carries the potential to harm yourself and others. In attempt to prevent these risks, we stress the importance of never cutting the seal, tampering with, or removing a meter for any reason without the assistance from the Co-op.

Our policy <u>requires</u> a trained co-op employee, using the proper protective equipment, to pull and reinstall any energized meter. To coordinate your work needs with our team, please provide a notice of two business days in advance by calling (800) 494-6272 during business hours (Monday through Friday, 8:00 a.m. to 4:00 p.m.).

warning: If an electrician or member does pull an electric meter to disconnect a service, significantly higher fees will incur. Disconnection or tampering of a meter sends a power outage alarm to the co-op. If a line crew responds to the outage, the member will be billed at the applicable line crew service call rate of \$370 during business hours, \$550 on evenings or Saturdays, and \$740 on a Sunday or holiday.

Your cooperation is appreciated. Our only goal is to protect you, your neighbors and our line workers from possible injury.

LOW-COST FINANCING | DEPENDING ON HOUSEHOLD INCOME

Center for Energy and Environment (CEE) offers financing for energy upgrades, including heat pumps, through several loan programs such as the MHFA Fix Up Fund, city-specific programs, and more. Approval is subject to program guidelines, please review all loan terms before applying.

STATE REBATES | UP TO \$4,000 (COMING SOON!)

Additional Minnesota state rebates will be available for heat pumps. To qualify, customers must:

- Apply for and/or receive the related federal rebate
- Have an energy audit within the last 18 months
- Perform necessary insulation upgrades
- Purchase and install heat pump of contractor-recommended capacity

MCLEOD CO-OP POWER REBATES | UP TO \$1,000

FEDERAL TAX CREDITS | UP TO \$2,000

Heat pumps installed between 1/1/2023 and 12/31/2032 may qualify for the Energy Efficient Home Improvement Credit (also known as the 25C tax credit). The amount of credit that can be claimed for a heat pump is equal to 30% of total project costs, up to \$2,000. A dual fuel system where a heat pump and furnace are both installed could qualify for \$2,600 (qualifying furnaces are eligible for an additional \$600 tax credit). Tax credits are subject to federal program availability.

UTILITY ELECTRIC RATES

Many utilities offer special electric rates that lower the cost to operate a heat pump. Visit our cost of heat comparison resource for help estimating your annual energy costs of operating a heat pump with different system configurations, utilities, and rate types.

During summer months, run large appliances that emit heat such as clothes dryers and dishwashers during the evening when the outdoor temperature is lower. Running heat-emitting appliances in the evening will reduce indoor heat gain during the day when outdoor temperatures are highest and ultimately keep your air conditioner from working harder than necessary.
